Governor rolled back limitation on playground and picnic areas. Took signs down. Outdoor restrictions now at 500. County health sent a confirmation regarding operations at the beach.

Kerri – internal swim meet Weds. Pancake breakfast held outside. Went well. Have you figured out social distance for the boardwalk? Limiting kids in lanes.

Peggy – Ladies of lake want clarification of waivers for activities – yes

BT – back dues 600k – large number. Heard from USDA (tree project). Would cost more to maintain rather than getting money for our lumber. Bc of embargo China is not importing out wood. Have until August to decide.

Denise – Lifeguards having issues with children not listening. Raft restriction rules not being adhered to. Parents of children will be spoken to. Beach privileges will be taken from kids that are not listening.

President – results of vacancy – Officer - John Farrelly. Trustee - Chris Merck. Chris is in attendance. John will be advised of the results.

Vernon Kelly Law money for 2018 still has not been received. Have conf call with Business administrator, CFO and Mayor on Tuesday to try to resolve our shot fall. Cost a little over 39k for snow removal. Max fund by town we are entitled 36k. Have offered 30k. Highland Lakes shorted 50k. One of costs excluding is backhoe as they said sand and salt are not an integral part of snow removal. Another thing they are doing is calculating a cost per mile than multiplied by a difficulty factor. In previous administration the road plowing difficulty was set at 1.5. Back in 2010 the Mayor commissioned a firm to look at all the lakes and set a difficulty factor. We would go from 1.5 to 1.38. Highland Lakes 1.15. Implement with 2019 season. If look at report, had a laundry list of other things town should consider. Elevation, curbing etc. Town only choosing aspects of report that will affect lakes negatively.

Highland Lakes spent \$250,000 putting in 98 speed bumps. 3 per mile. Would be a total of 15 for us. Currently have 7. Option we must consider. Cost is \$2-3k per speed hump which would be a sizable part of roads budget.

Inventory on street signs – probably need some painting volunteers. List of what is needed. Calls for nominations for even districts. Only got 1 nomination for District 6. District 2,4,8 and 10 have no nominations. Will send a call for vacancy elections.

Mike – 6:00 BBQ and movie Sunday at the Club

Bob – little algae on lake. Expected with limitation on treating to every other week. Good clarity. Great fishing, Reminder still catch and release. Larry has some concerns about the dam and fisheries. Has some concerns about the fish. Perhaps Tom Smith can help he has tanks at his store and is the off season. Laurie – fishing is good

Lynn – Comet has started. Have Covid plan, guard is wearing a mask

Larry – all good. Lots of bears every day. Bear went onto a house and they were trapped. If they are really a nuisance you can call. They don't scare. Bear hotline they will potentially come and relocate.

Tim – policy increase 12.5%. Have been shopping around think can do better
