Bob Smith asked for questions/comments on July 27th meeting minutes. There were no questions/comments. J. Nilsen motions to approve D. Ward seconds. Minutes pass.

Treasurer Report: Paul Foucaud

Balance Sheet:

7/31/19 balance \$435,000 Liabilities and committee funds totaling \$43,600 Community fund balance \$386,000

Income:

Our 2018 budget plans for 290 dues paying members. Through August 27th, we have 288 members that have paid or have signed a payment plan. We have 35 members with membership privileges suspended that have been referred to Dolan & Dolan for collections.

The outstanding dues balance is \$495,975. 35 pay plans with o/s balance 30k D&D Pay plans 9 Pay Plan 14

Kelly Law reimbursement submitted for 2108. Funds should be received in 4Q.

Expenses:

Through August bldg. and grounds over budget \$8k for lawnmower, taking out of Contingency fund in accordance with Board vote earlier this year.

Favorable Variances year to date: payroll taxes, Mangers Helper, B&S and Legal Unfavorable Variances year to date: Real Estate taxes increased \$1K, Truck payment and registration

Overall projected to be \$9K favorable

Lake treatments spending at a higher level

Roads & Bridges - no oil & chip with rainy spring & summer

Dock @ 106 Lakeside Dr – After completing dock inventory around the lake - propose new length is 17ft widest 31ft going forward

- Some have more than 1 dock, some have rafts
- Max coverage 341 sq. ft. Set as new standard
- Dock committee going forward will use this criteria. Hit reset and grandfather all current docks
- Any questions or comments from MC:

Dottie Ward – Why make largest the standard?

Looking to correct inconsistencies from when standards started. If someone installs without following procedures, enforcement action as violation of policies and procedures.

Nathalie Brill – Propose changing max width to 17ft.

Need to have some reason to set new standard. Cannot be arbitrary.

What is objection if all were 10x30?

Bob Smith asks for motion to adopt standards for dock installation: M. Curry motions, P. Merck seconds 10/17 vote yes, motion carries.

J. Matthews – on 8/18 Ladies of the Lake voted to fund management up to \$10K for the AC units for the Club.

Upgrade electric in club ~\$9K. Move main panels out of store into closet, Sub panel for store only. Sub panel for club room.
